If you do not you will forfeit the £100.00 agency fee and the property will become re-available to other prospective tenants.3. If you do not proceed with the tenancy after completing the tenancy application process, you will be charged under the forfeit procedure. If within 7 days of making the £100.00 agency fee payment, you pull out from taking the property you will lose the £100.00 agency fee held by Robert Rhys limited. If more than 14 days have elapsed since the time you first held the property by paying the agency fee, you will be liable for one full month's rent; due to the landlord.
